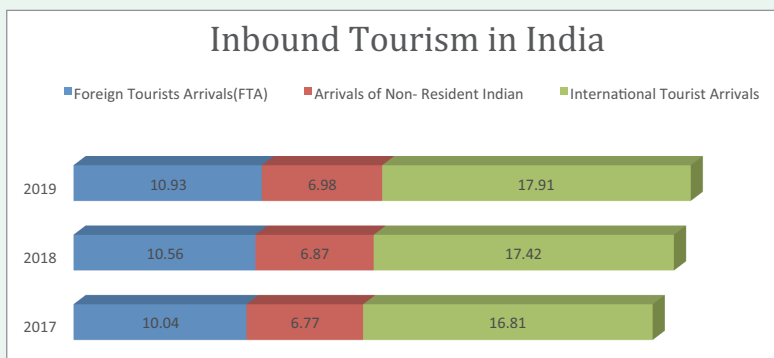

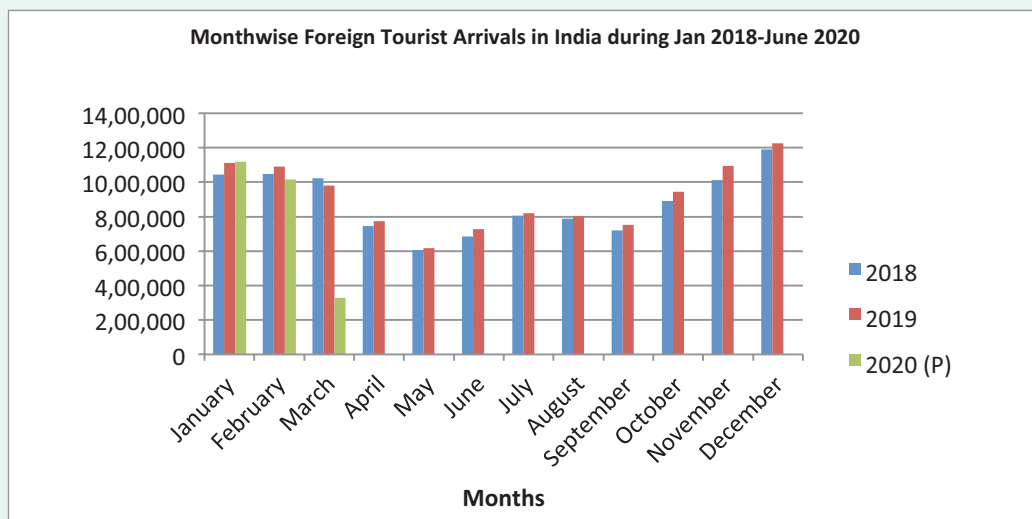

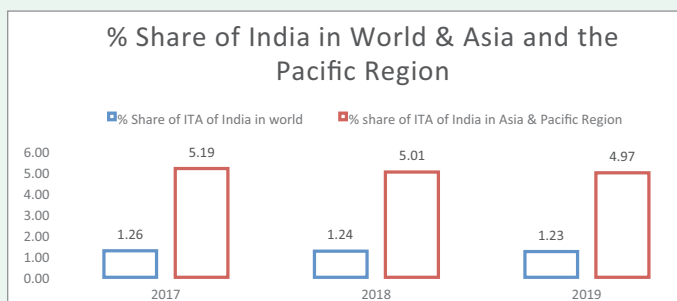

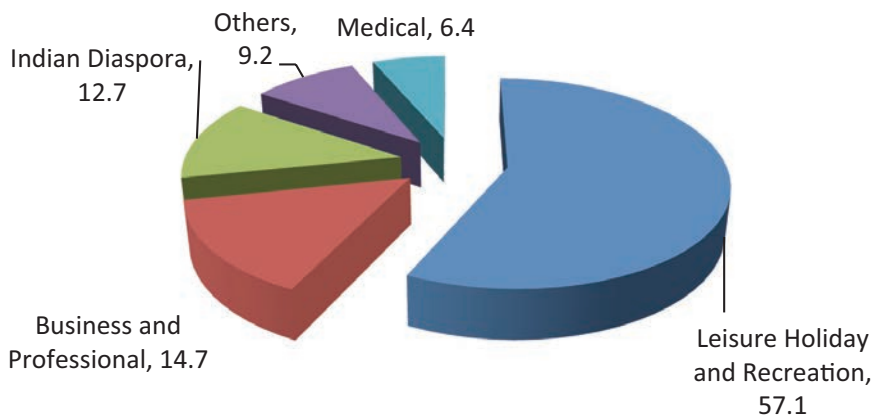

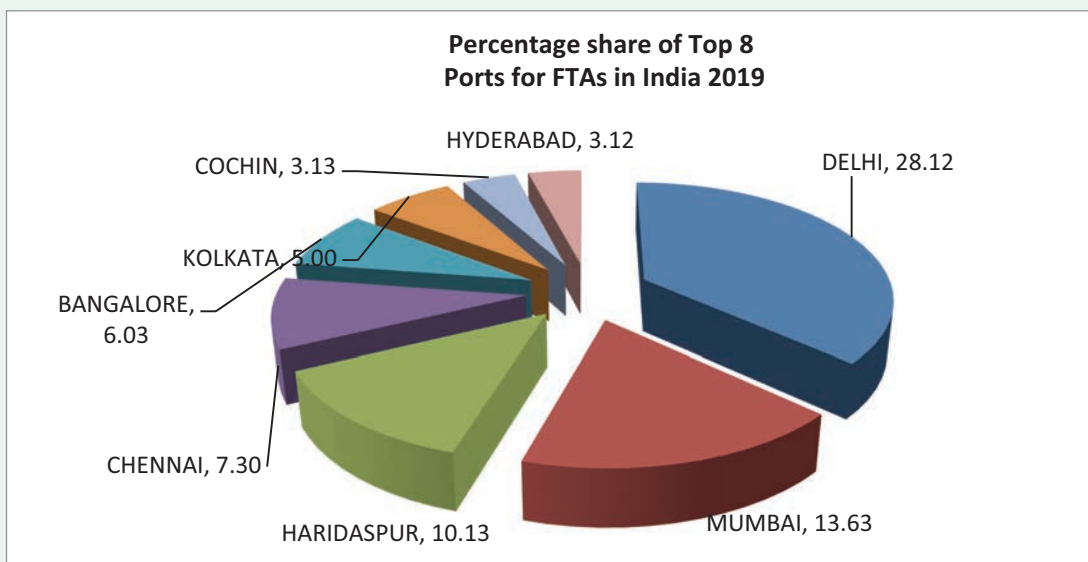

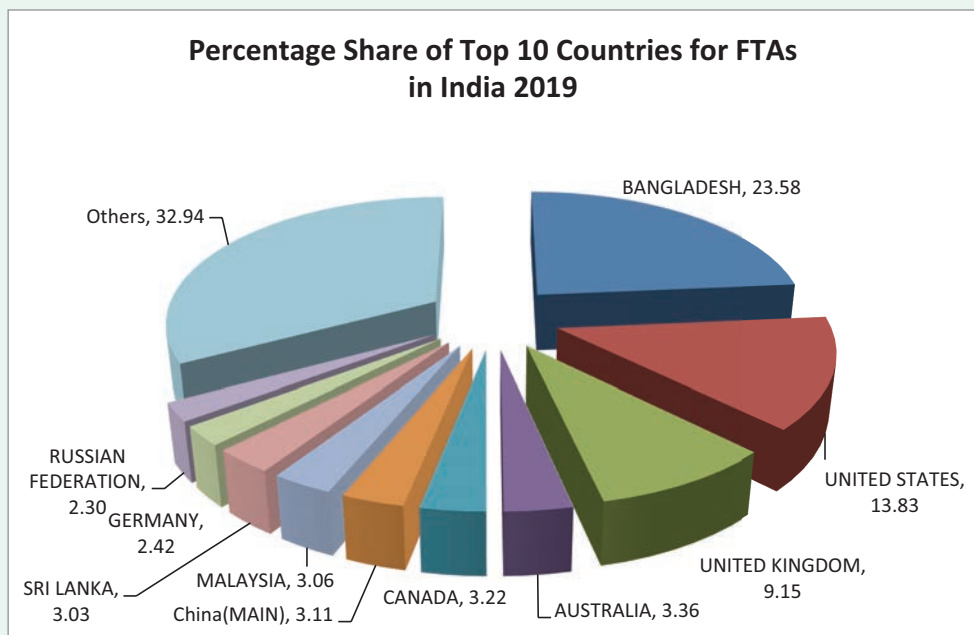

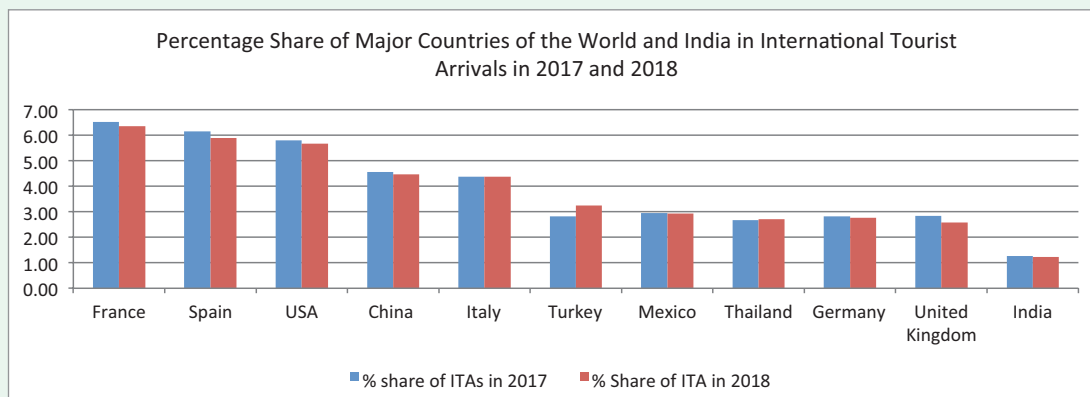

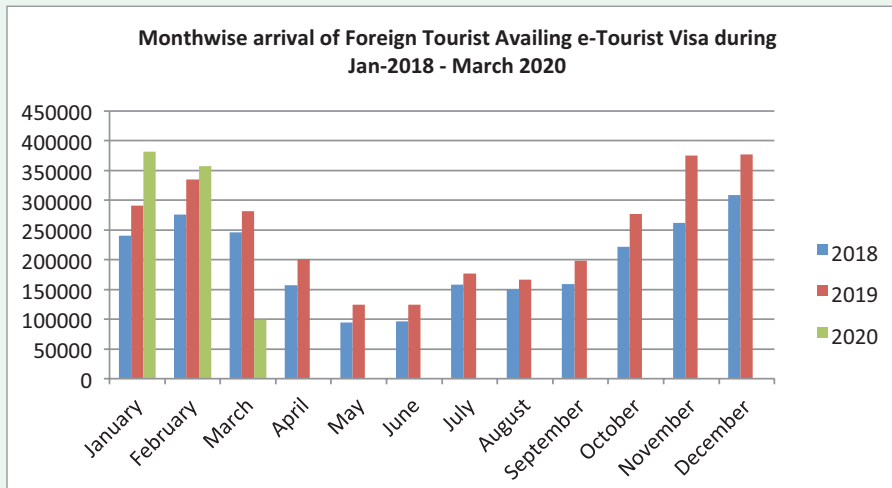

Airport wise Tourist availing e-Tourist Visa during 2019

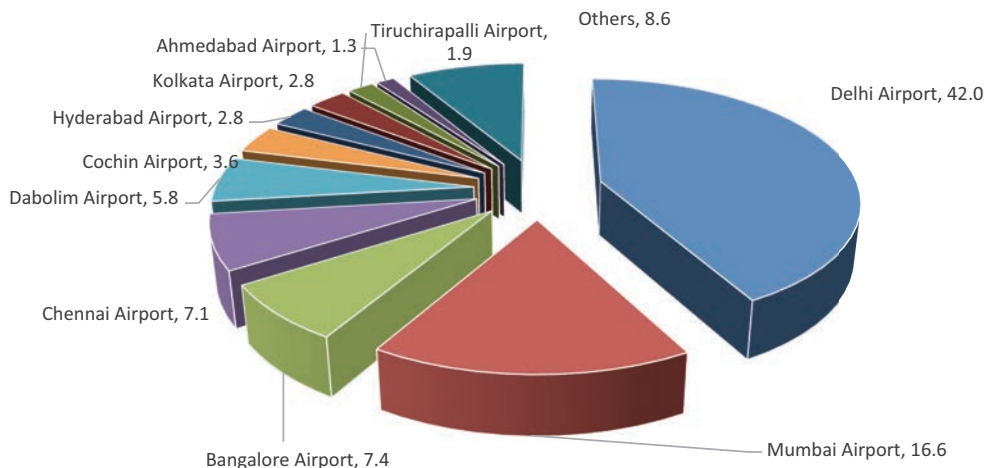

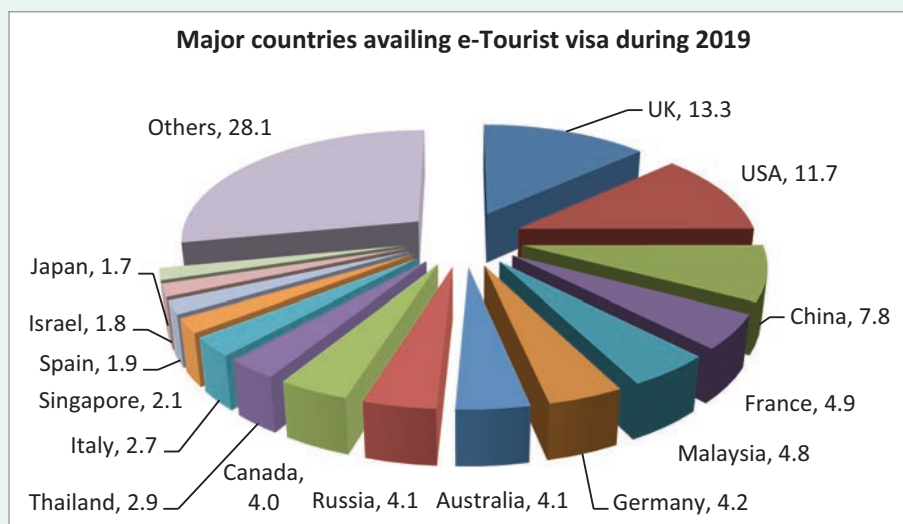

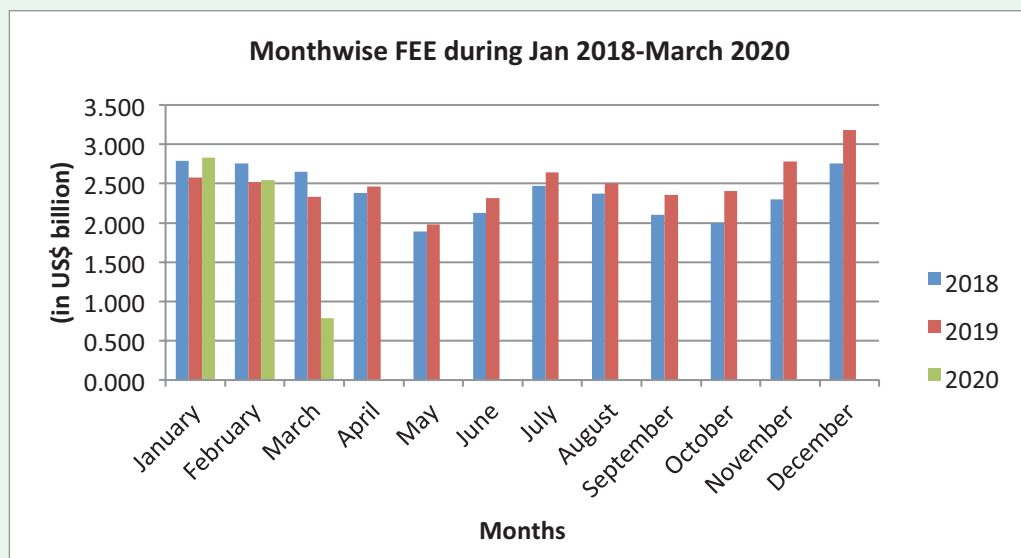

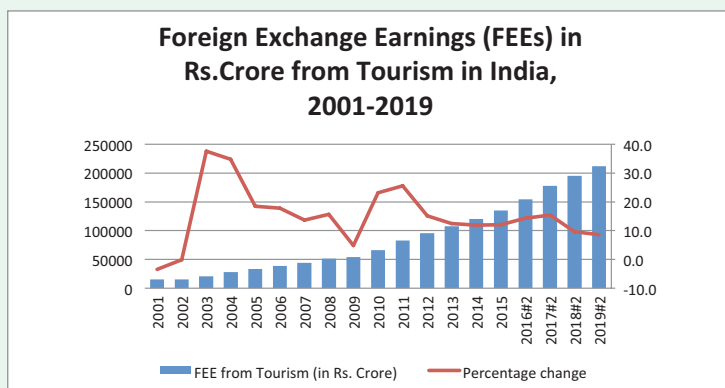

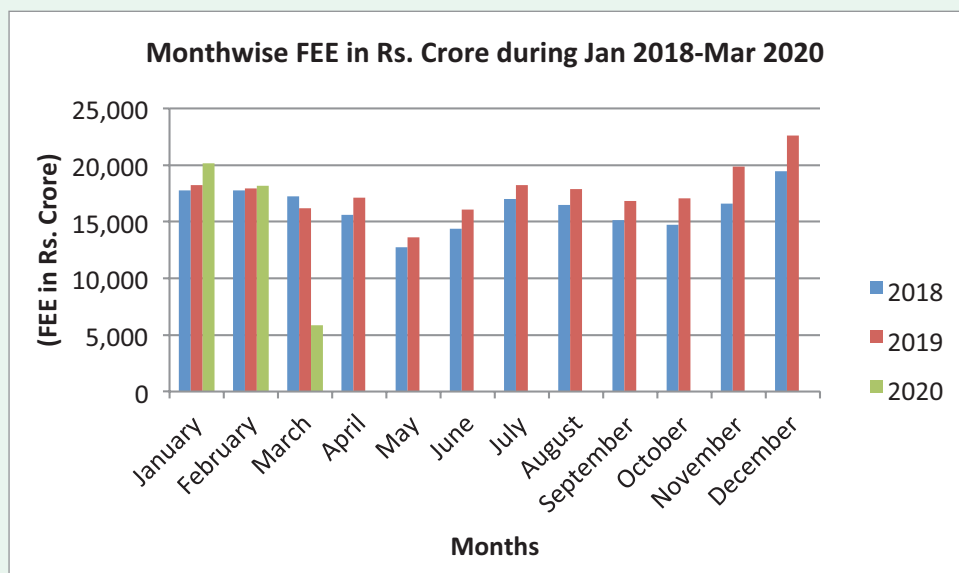

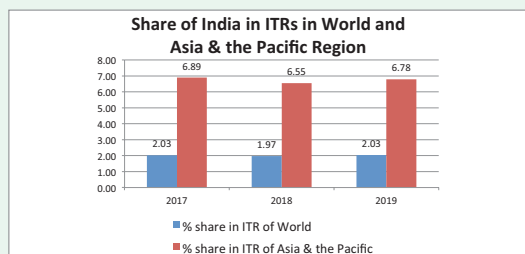

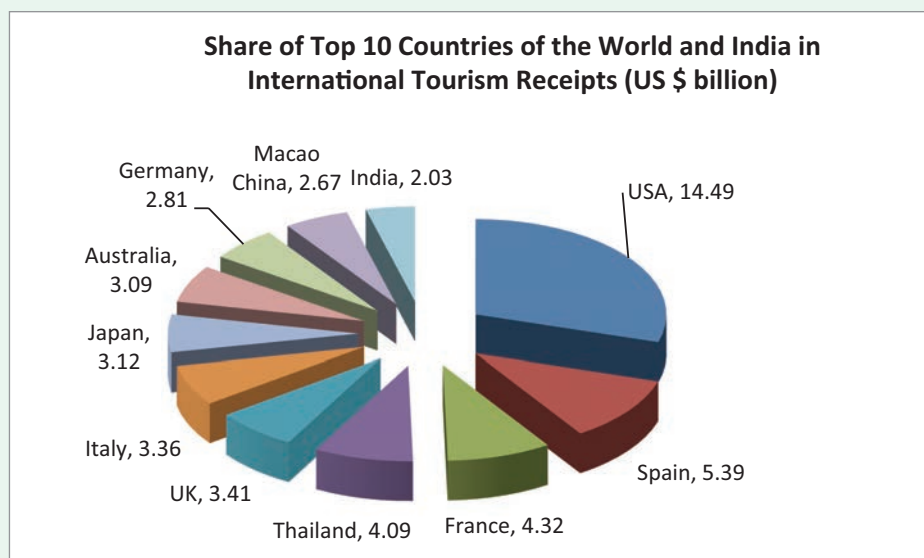

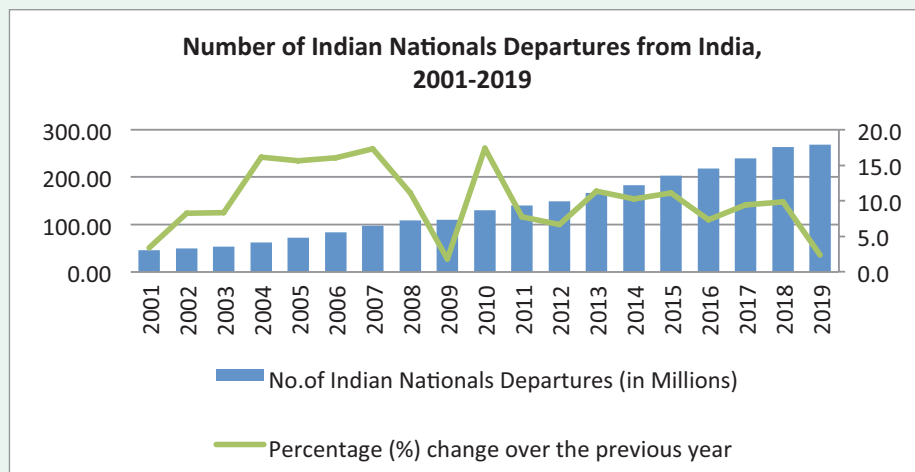

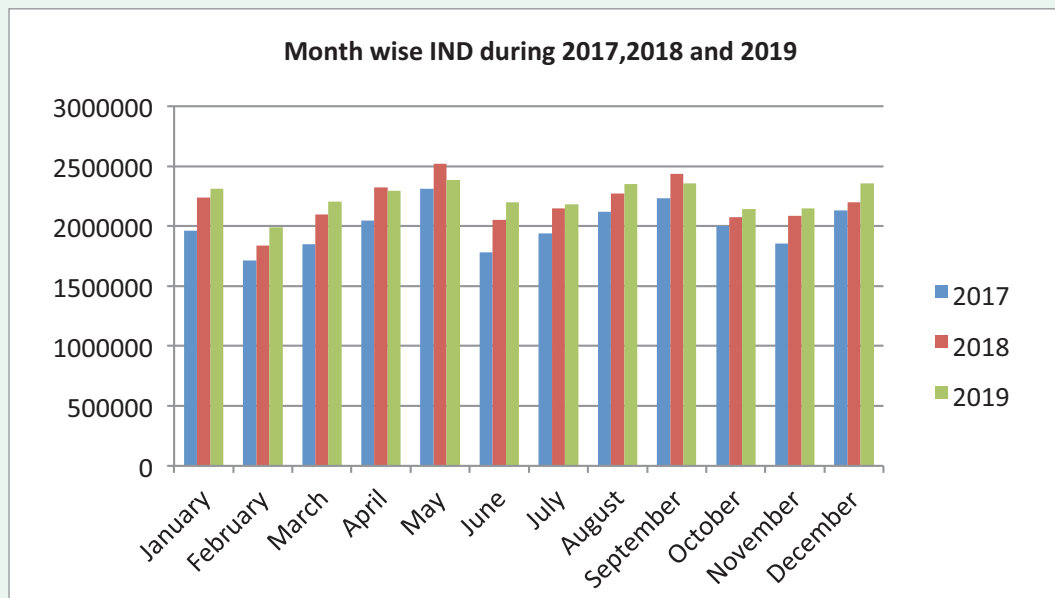

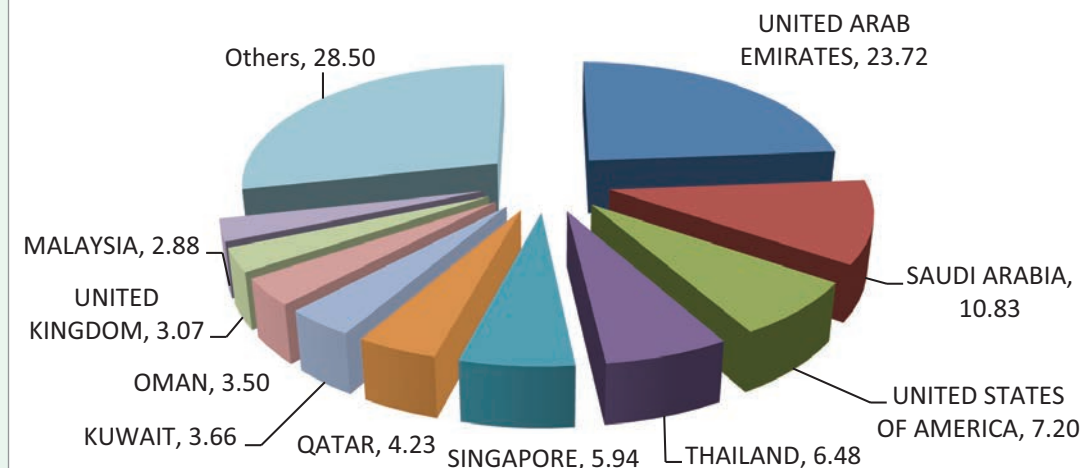

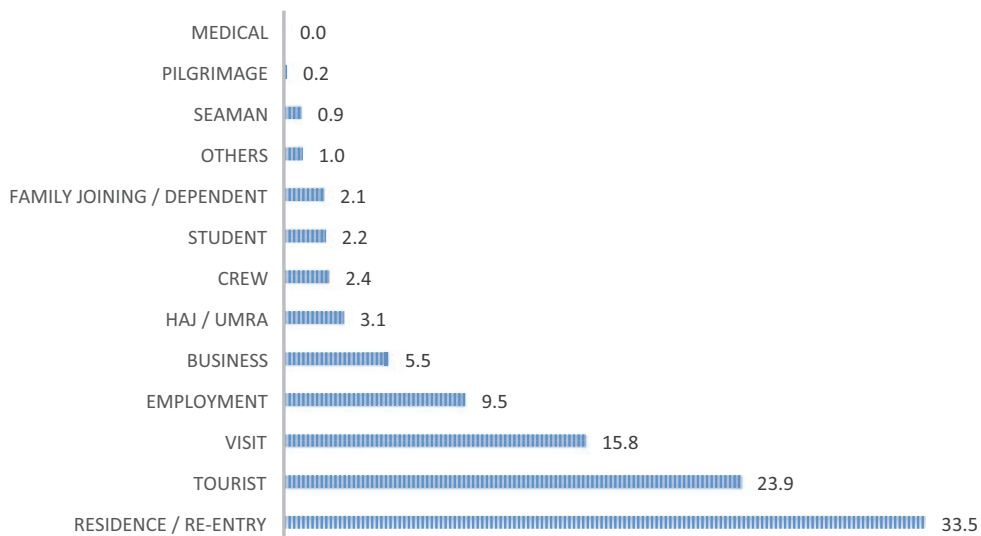

Percentare (%) Share of Top Ports for INDs from India in 2019

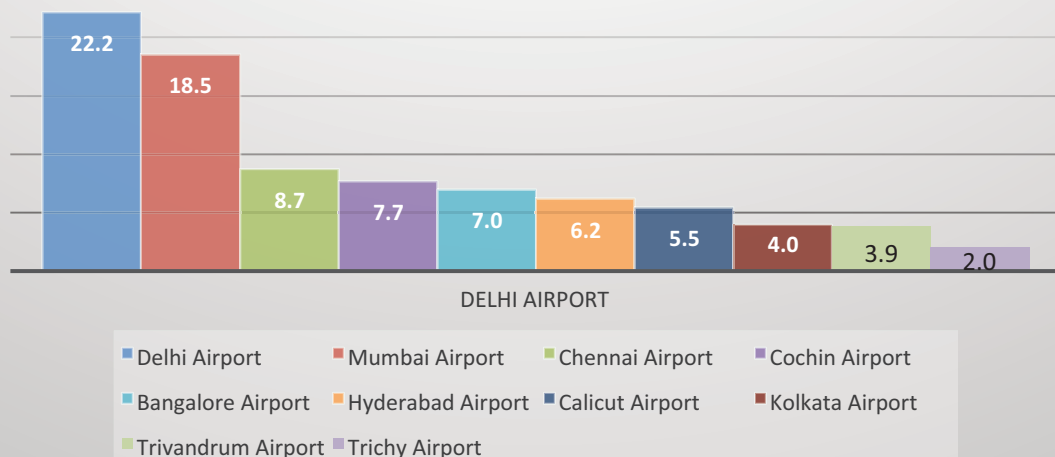

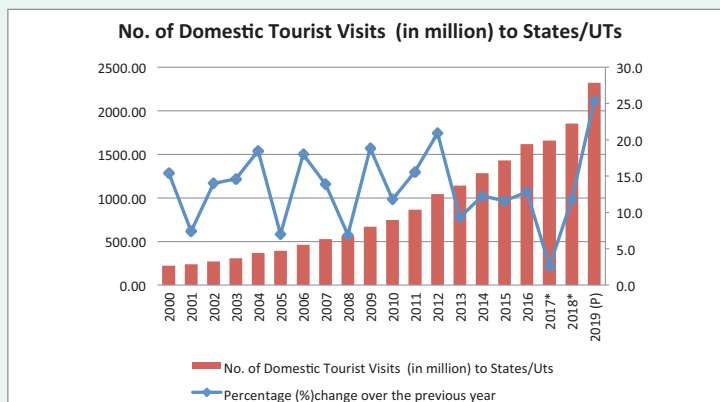

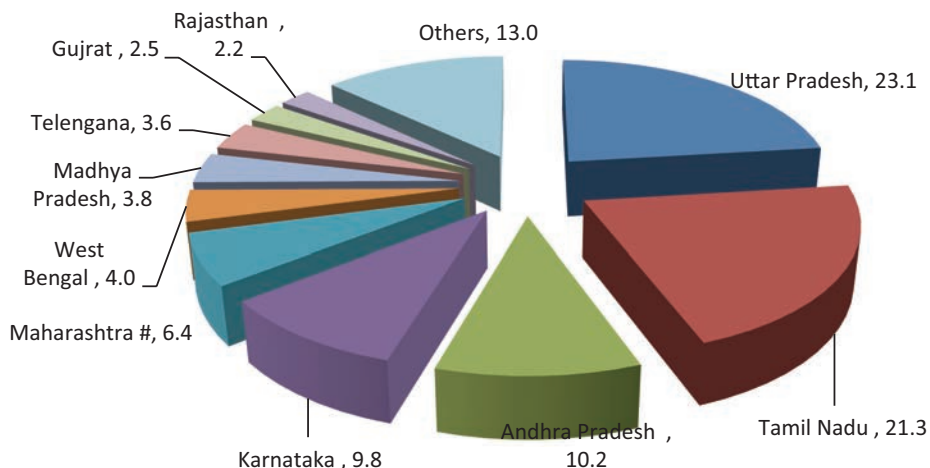

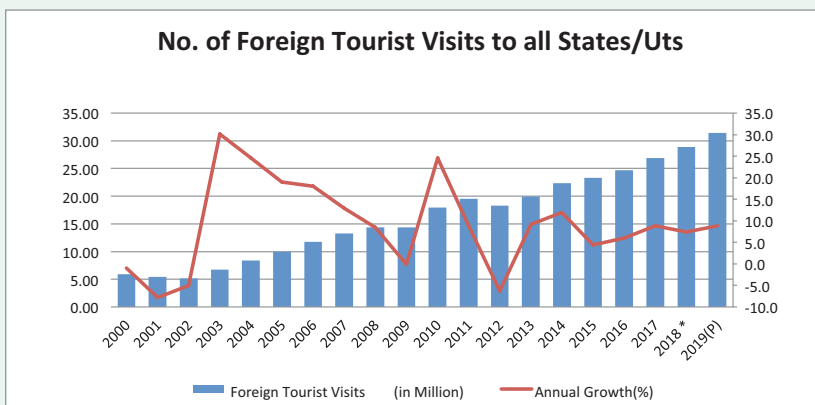

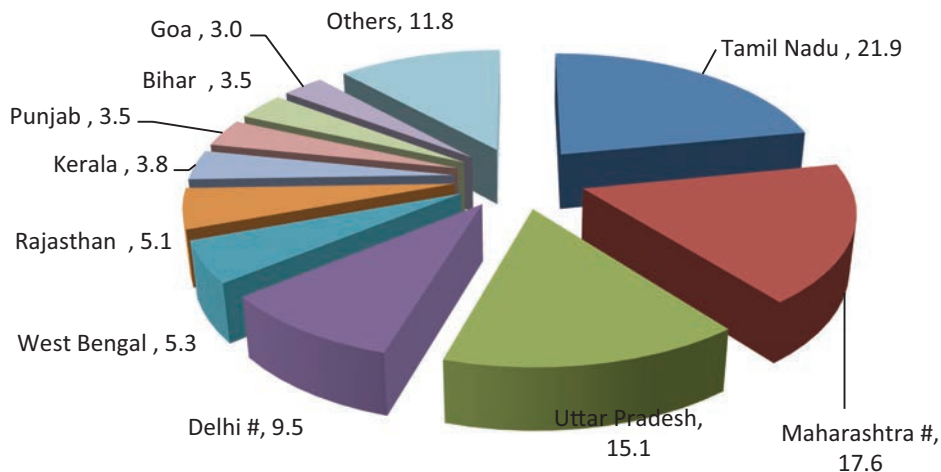
Share of Top 10 States/UTs in India in Number of Foreign Tourist Visits in 2019
